Reference is made to your recent query. Below is information which will guide you as how to proceed with your request regarding a Seychelles IBC.

Regarding such a company, this Authority is pleased to offer the following standard services:

**1. Company search:**

You can receive details in respect to IBCs which are registered with us by initiating a company search. Through the search you will obtain the following information:

- IBC number
- IBC Name
- Name of its Registered Agent
- Date of Incorporation, Share Capital
- Date next Fees are due
- Fees amount due
- whether the IBC is to be struck off, Year to strike off, whether the IBC is already struck off, the year it was struck off and finally -whether the company has been dissolved.

Please note that we are unable to provide information regarding shareholders and directors of companies.

**Company searches cost US\$100 each.**

**2. Certificates:**

You may also request standard certificates for an IBC, such as a certificate of incorporation, good standing and dissolution. An apostille may also be requested with the certificate.

Please note that we are only able to provide certified true copies of the original Certificate of Incorporation.

**Certificates cost US\$100 each.**

**Apostilles cost US\$12 each.**

The certificates may be sent to you via mail or courier (e.g. FEDEX or DHL). This can be arranged with SIBA and is charged separately.

**REQUESTING A SERVICE**

In order to initiate a search or request a certificate you need to forward to the Authority the requisite fee for each item requested, plus US\$25 for overseas bank charges. Note that all fees should be paid in advance before we can oblige. Once funds have been transferred, please forward a copy of bank transfer confirmation so that we can trace the fund.

**Please note that funds are not refundable, should the search prove to be negative.**

**METHODS OF PAYMENT**
